WHEREAS the Settler is desirous of establishing a Public Charitable Trust for the general welfare of the people of Manipur in the name and style of "MANIPUR STATE INTERNATIONAL UNIVERSITY MANAGEMENT AUTHORITY".

WHEREAS the Settlor himself is desirous of acting as a Trustee along with the other TWO Trustees above, who have at the request of the Settlor agreed to act as Trustees of the present Public Charitable Trust upon the terms and conditions hereinafter contained.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. In order to effectuate the said object of creating and establishing a public charitable trust, the settlor herein delivered to and made over to the Trustees a sum of Rs. 1,00,000/- (Rupees One Lakh Only) with intent to part with all his rights, title, interest and claim therein and vest the same in the Trustees to have and to hold the same and all other properties that may for the time being represent the Trust estate together with all additions and accretions thereto and all accumulated income thereof and all other properties that may be acquired out of the same or otherwise may hereinafter be subject to the Trust (hereinafter referred to as THE TRUST FUND) for the charitable objects and purposes and uses them as hereinafter expressed with the powers and on the terms and conditions herein contained.

2. Name of the Trust shall be " MANIPUR STATE INTERNATIONAL UNIVERSITY MANAGEMENT AUTHORITY"

3. Office of the Trust shall be situated at C/o Pushparaj, Ningthoukhong, Post and PS Ningthoukhong, Bishnupur District, Manipur State - 795126, India which may be changed from time to time to such other place or places as the Board of Trustees may deem fit and proper at their discretion.

4. The AIMS and OBJECTIVES of the Trust shall be:

- i) To propose, support, promote. establish and to manage an International Institution of Higher Education / an International University of Highest Repute and quality in the State of Manipur and in all other States.

- ii) To promote and support the concept of free education for the underprivileged and the needy.
- iii) To promote, support and to undertake extensive research, education and training in various subjects at all levels.
- iv) To undertake and to provide consultancy and research services on various subject/s.
- v) To cooperate with various other institutes, bodies, departments, organizations and the Universities etc., in India and abroad having objects wholly or partly similar to those of this Trust.
- vi) To provide instruction, teaching and training in all subjects at all levels and to make provisions for research, advancement and dissemination of knowledge.

OTHERS

- i) To undertake any such activities aimed at ameliorating the lot of the weaker and vulnerable section of the population as well as of women and girl in terms of their economic, social and political standing in the society.
- ii) And to undertake other jobs considered necessary and ancillary to attain the above mentioned main and other objectives.

5. The Aims and Objects of the Trust shall be purely for "PUBLIC CHARITABLE PURPOSE/S".

6. The Trust Fund shall consist/ comprise of:

- i. The amount of Rs. 1,00,000/- (Rupees one lakh only) which has been delivered by the settler / founder of the trust;
- ii. Any other amount or any kind of property which the trustee/s may contribute to the fund in lump sum or by way of periodical installment or in any other manner as may be desired by the trustee/s.
- iii. Donations, grants, presents, gifts, and other offerings in the shape of movable and/ or immovable properties which may be given by the trustee/s or any other individual or organization or any other entities to the trust and which has been accepted by the trust;
- iv. Grants/ funding by governmental and / or non- governmental entities which may be accepted by the trust to its Fund;
- v. Funds which may be raised by the trust through ways and means which are legal in nature including investment of part of the trust fund or otherwise for the attainment of the AIMS AND OBJECTS of the TRUST.

7. The trust fund shall be kept in an account which may be opened in a scheduled bank in the name of the trust.

8. For the implementation and fulfillment of the aims and objects of the Trust, it may purchase/ acquire/ lease land and/ or building in the Name of the Trust and also hold and manage the assets and properties acquired/ inherited or purchased by the Trust for the achievement / advancement of the aims and objectives of the Trust.

9. The trust can also erect, construct, alter, maintain, sell, lease, mortgage, transfer, improve, develop, manage and control all or any part of property or building of the Trust, as may be necessary or convenient for the purpose of the attainment of the aims and objects of the Trust.

10. It is within the capacity of the Trust to invest its money and funds after due decision to the effect for the betterment of the trust and towards fulfillment of its aims and objects.

11. The Trust can receive assistance financial/ non-financial from any individual/ non-governmental organization or governmental entities towards the fulfillment of the aims and objectives of the Trust.

12. The Trust may tie-up with any individual/ groups/ non-governmental or governmental entities to perform certain work/ activities towards the fulfillment of the aims of objects of the Trust.

13. The Trust may appoint any employee as may be required after due deliberation and it also reserves the powers to terminate the services of any staff as may be deem fit and proper for the benefit of the Trust.

14. All Trustees together shall form the BOARD OF TRUSTEES which shall be responsible for the proper management and running of the trust and the Settlor himself shall act as the Executive Trustee of the board from its inception/ registration and he shall continue so to act till his death or he relinquishes the chairmanship as per the rules of the Trust.

15. The first board of trustees shall be constituted by Dr. HARIKUMAR Pallathadka (as Secretary), Mr. Nirnay Jain (as Chairman) and Mr. Pushparaj (as President) and as they retire or resign, they may nominate a trustee of their choice with in a period of fifteen days from the date of their retirement or resignation and on their failure to do so, Board of Trustees shall appoint a new trustee of their choice.

16. It is hereby declared that no part of the Trust property or its income shall be applied for any purpose other than for the attainment of the aims and objects of the Trust.

17. Trustee/s shall be the Trustee/s for their Life Time if not removed earlier as per rules but any trustee may resign by giving in written to the President of the trust and in case the President of the trust wants to retire, he may do so by writing to the Chairman of the Trust.

18. Decision on any issue of the Trust shall be taken by the Board in a meeting to be presided over by the Secretary after due deliberation and in case of any difference of opinion among the trustees, the decision of the Secretary shall be final.

19. The Board of Trustees may from time to time frame rules for the proper conduct of the administration and management of the Trust and regulating the meetings of Board of Trustees and also for regulating the services of the employees if any and also for any other reason/s or purpose/s which the trust may deem necessary. In absence of such regulations all the matters will be decided by the Board of Trustees and the quorum for the board meeting shall be two third.

20. Regular accounts shall be maintained relating to all receipts, payments, income, expenditure or any property or liabilities relating to the Trust. Further the accounts of the Trust will be audited by a qualified auditor on a periodical basis.

21. The Trust shall sue and shall be sued in the name of the of Trust.

22. No remuneration or other benefits in money or money's worth shall be given by the trust to any of the TRUSTEES, whether its office bearers or servants except payment of out of pocket expenses incurred in connection with the work of the trust.

23. All the incomes, earnings, movable / immovable properties of the trust shall be solely utilized and applied towards the promotion of its aims and object only as set forth in the Memorandum of the trust and no profit, thereof shall be paid or transferred directly or indirectly by way of dividends, bonus, profits or in any other manner whatsoever to the present or past members of the trust or to any person claiming through any one or more of the present or the past members.

24. The Trust is and shall be an International, non- government, non- political, non- religious, non-sectarian, non-domination, non-community, non-profit making, research oriented, secular, educational, social development and voluntary organization. It seeks to raise the educational, economic, social and cultural infrastructures of India irrespective of Age, Rank, Race, Nationality, Caste, Creed, Community and Religion etc.

25. At all times the Secretary of the trust shall be the authorized signatory on behalf of the trust and he shall sign all the documents, letters & instruments on behalf of the Trust. Any document or instrument not signed by the Secretary of the trust shall not be an authorized or valid document/instrument of the trust at any point of time and it shall be treated as null and void or as of no value.

26. All the bank accounts in the name of the Trust shall be operated solely by the Secretary of Trust.

27. The Trustees shall at all times observe the confidentiality of the affairs of the trust.

28. Every Trustee and every person appointed as a Trustee thereafter under the trust above shall be indemnified out of the Trust property against all losses and expenses incurred in the discharge of his duties except such as shall happen through own willful neglect, willful act or willful default and each Trustee or person shall be chargeable with only such money or property as he shall himself actually receive for or in the discharge of the affairs of The trust and each one shall be answerable only for his own acts, neglects or defaults and not for those of any other person.

29. No Trustee / member of the trust shall have any personal claim on any moveable or immovable properties of the trust or make any profits, whatsoever, by virtue of any membership.

30. The benefits of all the above charitable and social services extend to the Whole of India and shall be to all people irrespective of nationality, caste, creed, color, community, religion, gender or sex.

31. The Trust hereby created shall be irrevocable.

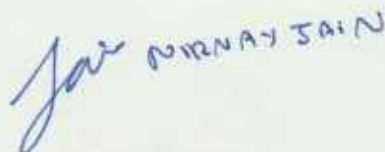

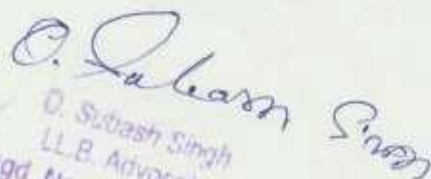

5. That, the 2nd Party shall manage the trust funds, income, assets and properties (movable and immovable) acquired/donated or purchased by the Manipur International University Management Authority Management Authority or any other investment made by it from the day of take over i.e. last day of March, 2025.
6. That, the 1st Party has also agreed that 2nd Party at all times shall ~~be the~~ Authorized Signatory on behalf of the Manipur International University Management Authority Management Authority and he shall sign all the documents, letters and instruments on behalf of the Trust from the day of take over i.e last day of March, 2025.
7. That, all the Bank Accounts in the names of the Manipur International University Management Authority or Trust or its subsidiaries shall be operated by the 2nd Party or by a person or persons appointed by the 2nd Party for the purpose from the day of take over i.e. last day of March, 2025.
6. That, this deed will take effect from the last day of March, 2025 and will be valid unless cancelled otherwise.
7. That, this deed is cancellable at any point of time by mutual agreement of the parties.

Okram Henry Singh, Chairman of Manipur International University Management Authority.

DEED OF AGREEMENT

This Deed of AGREEMENT OF Relinquishment is executed on this 20th day of September 2024, between Dr. Harikumar Pallathadka, Aged about 40 years, S/o Late Shankara Narayana Bhat, a permanent resident of Subraya Sadanam, Pallathadka, Post Pallathadka, Village and P.S. Badiadka, Kasaragod Taluk and District, Kerala State, India -671551 (Aadhar Card No. 2612 5458 2966) presently residing at Ghari Awang Leikai, Imphal, Post Tulihal, P.S. Lamphel, Imphal West, Manipur -795140 hereinafter as the 1st Party on one part and Shri. Okram Henry Singh, Aged about 39 Years, S/o Late O. Lukhoi Singh of Khurai Ahongei, Post and P.S. Porompat, District Imphal East, Manipur as the 2nd Party on the other part.

Whereas the 1st Party is the Settler and Secretary of the Manipur International University Management Authority and 2nd Party is the Chairman of the Manipur International University Management Authority.

And Whereas, the 1st Party is desirous to release/relinquish all powers, responsibilities and functions of the Secretary and same are handed over to the 2nd Party with all his free will and consent without any duress or coercion from any quarter.

And Whereas, the 2nd Party has also agreed to take over all powers, responsibilities and functions of the 1st Party for the welfare of the Manipur International University Management Authority.

Now, the 1st Party and 2nd Party has agreed in the following term and conditions:

TERMS AND CONDITIONS OF THIS DEED OF RELINQUISHMENT:

1. That, the First Party shall clear the dues payable to the 2nd Party which was invested by the 2nd Party to Settler and Secretary i.e. 1st Party for the development works of the Manipur International University Management Authority within 6 (Six) months from the date of execution of this deed. In case the said payment is done within the promised period then this Deed will be deemed null and void.

2. That, the First Party will sincerely try to pay substantial part as soon as possible and as much as possible against proper acknowledgement preferably starting from the month of September 2024 itself.

3. That, the First Party agreed that he will release/relinquish all the powers, responsibilities and functions of the Settlor and Secretary of the Manipur International University Management Authority and same will be handed over to the 2nd Party from the last day of March, 2025.

4. That, the Second Party agreed that the 2nd Party shall take over the charge of all powers, responsibilities and functions of the Settlor and Secretary of the Manipur International University Management Authority from the last day of March, 2025 and 1st Party shall not intervene in the work and function of the 2nd Party from there onwards.

5. That, the 2nd Party shall manage the trust funds, income, assets and properties (movable and immovable) acquired/donated or purchased by the Manipur International University Management Authority or any other investment made by it from the day of take over i.e. last day of March, 2025.

6. That, the 1st Party has also agreed that 2nd Party at all times shall be the Authorized Signatory on behalf of the Manipur International University Management Authority and he shall sign all the documents, letters and instruments on behalf of the Trust from the day of take over i.e. last day of March, 2025.

7. That, all the Bank Accounts in the names of the Manipur International University Management Authority or Trust or its subsidiaries shall be operated by the 2nd Party or by a person or persons appointed by the 2nd Party for the purpose from the day of take over i.e. last day of March, 2025.

6. That, this deed will take effect from the last day of March, 2025 and will be valid unless cancelled otherwise.

7. That, this deed is cancellable at any point of time by mutual agreement of the parties.
